- **City of Rock Hill General Election Updates-** A. Helms shared that on Monday, June 5, the York County Council accepted via consent agenda the first reading to rescind the ordinance allowing York County to run Rock Hill's municipal election. The City of Rock Hill has submitted a Memorandum of Understanding for review related to moving their municipal elections to a November calendar. The ordinance will have its second reading tonight at the York County Council meeting.
- **Municipal Candidate Filing-** A. Helms shared a presentation explaining the contents of the candidate filing packet; designed to set expectations for quality, integrity, and candidate actions. Strong emphasis on ethics and the state's requirements. Process is transparent and candidate information is posted in near-real time on scVOTES.gov. (Attachment)
 - A. Helms also explained that the filing fees are paid to York County to offset a minimum of election expenses. He also noted that candidate qualifications are set by the jurisdictions.
